#### **Absences**

All applicants selected to participate in the Leadership Academy are expected to fulfill all the obligations indicated above.

It is the sole responsibility of the participant to communicate in writing prior to the date of the class all anticipated and/or actual full or partial day absences to the staff liaison of the Leadership Academy, along with an explanation of the circumstance for the absence. Absences must be approved by the Leadership Academy Board. If this expectation is not met, the applicant, after review, may be dismissed from the program with no refund of tuition.

- 1. Less than or equal to two hours
- 2. Greater than two hours, but less than or equal to four hours
- 3. Greater than four hours, but less than or equal to five hours
- 4. In excess of five hours
