REALTOR® OF THE YEAR AWARD

This award is given to the member who once in a lifetime exemplifies what it means to be a REALTOR®. They have been active in the Association and community, contributing freely of themselves and their talents. They are ongoing examples of the professionalism exemplified by the Code of Ethics to which they subscribe.

- **REALTOR® Spirit:** Commitment to laws and regulations of the Association and the National Association of REALTORS® Code of Ethics; Dedicated to furthering principles of good real estate practice among other real estate brokers, the media and the general public.
- **Civic Affairs Activity:** Local and national level participation in civic and service clubs, charitable activities, political commissions or committees, fraternal or religious groups, etc.
- **Business Accomplishments:** Public recognition of business conduct, service to clients, imaginative and creative advertising programs, rehabilitation work, land utilization, etc.
- **Local Association Activity:** Committee work, special assignments, seminar activity and educational work, membership and offices held in local chapter or institutes, etc.
- **State Association Activity:** Committee work, attendance and participation in state convention, director's meetings, educational conferences, etc. (not required for nomination)
- **NAR Activity:** Committee work, membership and work in institutes, societies and councils, attendance at national conventions, director's meetings, etc. (not required for nomination)

ROOKIE OF THE YEAR AWARD

This award honors a deserving "Rookie" with 3 years or less tenure in the real estate profession. Criteria should include but is not limited to:

- Circle of Excellence recipient verification/ broker verification
- Tenure as a REALTOR® three(3) years or less
- Ethical practices.
- Participation in association activities.
- Active in community affairs.
